### **Transfer Stations – Illegal Dumping**

Further to lengthy discussion at our AGM with Bruce Gibbon, Bruce has

since advised cameras on a 7/24 basis have been installed at the Brooks Rd station with numerous charges being laid. In addition a portable unit is now in effect at our local station with charges being laid there. ### **Foley Community Center Complex**

The Task Force Committee over a period of two years put a lot of effort and time in coming up with a final recommended package of a Foley community Multipurpose Community Center/Library and Fire Hall Complex. There recommendation was presented to Seguin Council on September 19<sup>th</sup> this year.

As I am given to understand, Council reviewed the proposal, and advised the Task Force, that unfortunately the Township currently does not have money in their budget to proceed with their portion of the presentation. (The overall project is estimated to cost about \$6.2 million). The Township is taking the presentation under consideration with their staff, reviewing and considering possible alternatives.
